Airborne transmission of COVID-19	Ensembles including woodwind and brass instruments	Wind and brass pupils should be staggered within the space if in multiple rows so not positioned directly in front of each other, should not be facing each other and should be at least 1m apart. Airborne/surface transmission of COVID-19	Tutors who are extremely clinically vulnerable (CEV), or live with a household member who is extremely vulnerable	From April 1 st 2021 the Government have paused the shielding measures and tutors who are CEV are therefore able to return to working in schools.	M	Any tutors who are still independently advised by their doctor to shield beyond 1st April should contact the Head of EMS to discuss this further.	EMS/ Tutors - ongoing
Tutors who have higher risk factors to Covid-19 such as: • Shielding staff • Clinically vulnerable (over 70 or underlying health conditions) • Pregnant • BAME • Carer for a vulnerable person • Men over 40	Tutors with protected characteristics Emerging evidence suggests that alongside underlying he alth conditions, there are key demographic factors that can affect people's vulnerability or is a 'risk factor' in relation to COVID-19. The causes of these increased risk factors are not yet fully understood, and further research is taking place.	Tutors who have concerns about additional risk factors should discuss these concerns with the Head of EMS. Where there is agreement that the risk factors can be mitigated with the existing control measures in the risk assessment to everyone's satisfaction no change is needed. Where however it is clear there is increased risk for a staff member which is not mitigated by the existing control measures support will be provided to make necessary adjustments to further mitigate those risks.	L	Tutors can opt to wear a mask and/or gloves whilst teaching and potentially stand behind a screen.	EMS/EMS Tutors - ongoing

Tutors with COVID-19 symptoms and potentially spreading to staff and others	Everyone	Tutors who become symptomatic whilst attending an EMS out of school setting should inform the Head of EMS or Sean Turpin immediately and follow protocols as requested.	L		EMS tutors - ongoing

		Tutors should not attend an EMS out of school setting if they display any symptoms of COVID-19 and should follow the latest Government guidance on self-isolation. If a tutor is a household contact of someone who becomes symptomatic, the tutor should follow the relevant Government guidance depending on vaccination status: https://www.nhs.uk/conditions/coronavirus-covid-19/self-isolation-and-treatment/when-to-self-isolate-and-what-to-do/ Tutors should inform the Head of EMS as soon as possible if they test positive for Covid-19.		
Tutors with COVID-19 symptoms and potentially spreading to staff and others	Everyone	Pupils should not attend if they have any symptoms of Covid, are required to quarantine, have been instructed to self-isolate and/or receive a positive test. Parents should contact the Head of EMS if a pupil tests positive and cease to attend rehearsals until their isolation period ends and they are symptom-free.	L	Everyone - ongoing
