#### Advance level - 90 minutes

- To be able to risk assess and manage the risk to support victims / children work with case studies
- To learn how practitioners can identify the risks in an agency setting and safety plan -
- To understand the Forced Marriage Protection Legislation (Criminal & FMPOs) & immigration / policy to support victims with No Recourse to Public Funds (Spousal Visa only)

## **Managing Allegations of Abuse Against Staff & Volunteers**

Aim and objectives of this session:

To understand the role of the Local Authority Designated Officer (LADO).

For participants to feel confident about their roles and responsibilities in managing allegations, the threshold if concerned about someone who works with children, and when to refer to the LADO.

For participants to be confident about the LADO referral process, how allegations are managed, and possible outcomes.

For participants be confident about when and how to notify the appropriate regulatory bodies and/or to refer individuals to the Disclosure and Barring Service (DBS).

Prevent aims to stop people becoming terrorists or supporting terrorism by working with some government departments, local authorities and community organisations.

respond to the ideological challenge of terrorism and the threat from those who promote it prevent people from being drawn into terrorism and ensure they are given the right advice and support

work with institutions where there are risks of radicalisation that need to be addressed
