WHAT IS A RIGHTS RESPECTING SCHOOL?

A Rights Respecting School puts the United Nations Convention on the Rights of the Child at the heart of a school's culture and ethos to improve well-being and develop every child's talents and abilities to their fullest potential.

This short film was co-created with children and young people at four Rights Respecting Schools in the UK. It shows the impact of the Rights Respecting School Award, and the difference it makes to children's lives when they learn about their rights.

Teaching and learning for rights

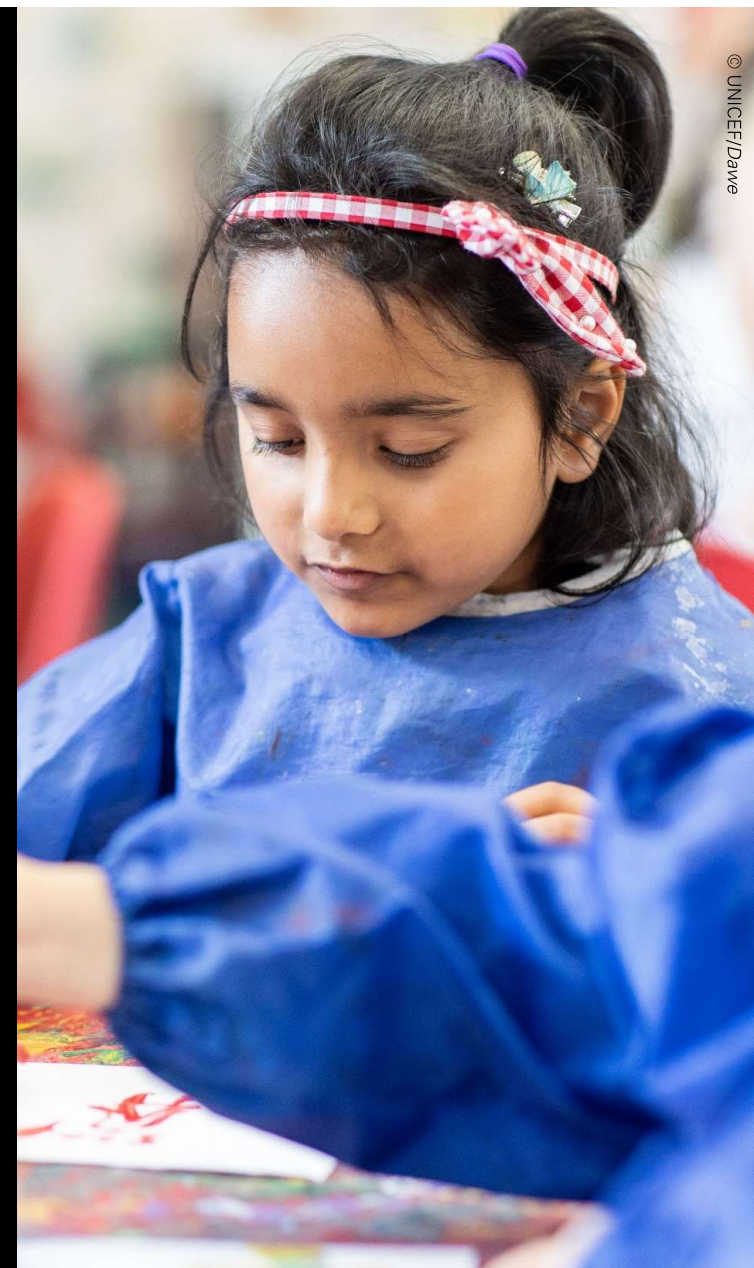


IMPACT

- As a result of participation in the RRSA award children in schools:
 - Know about rights
 - Can exercise their rights
 - Feel valued
 - Can recognise the rights of others
- At our accreditation visits, school leaders tell us that RRSA impacts on:
 - Relationships
 - Inclusion
 - Safeguarding and wellbeing
 - Participation and pupil voice
- Full Impact Report available on the website

Relationships at all levels are respectful. This is built on the school's emphasis on respecting each other's rights. Pupils articulate confidently that they have the right to learn and play. They are confident they can share with staff any concerns they may have'.

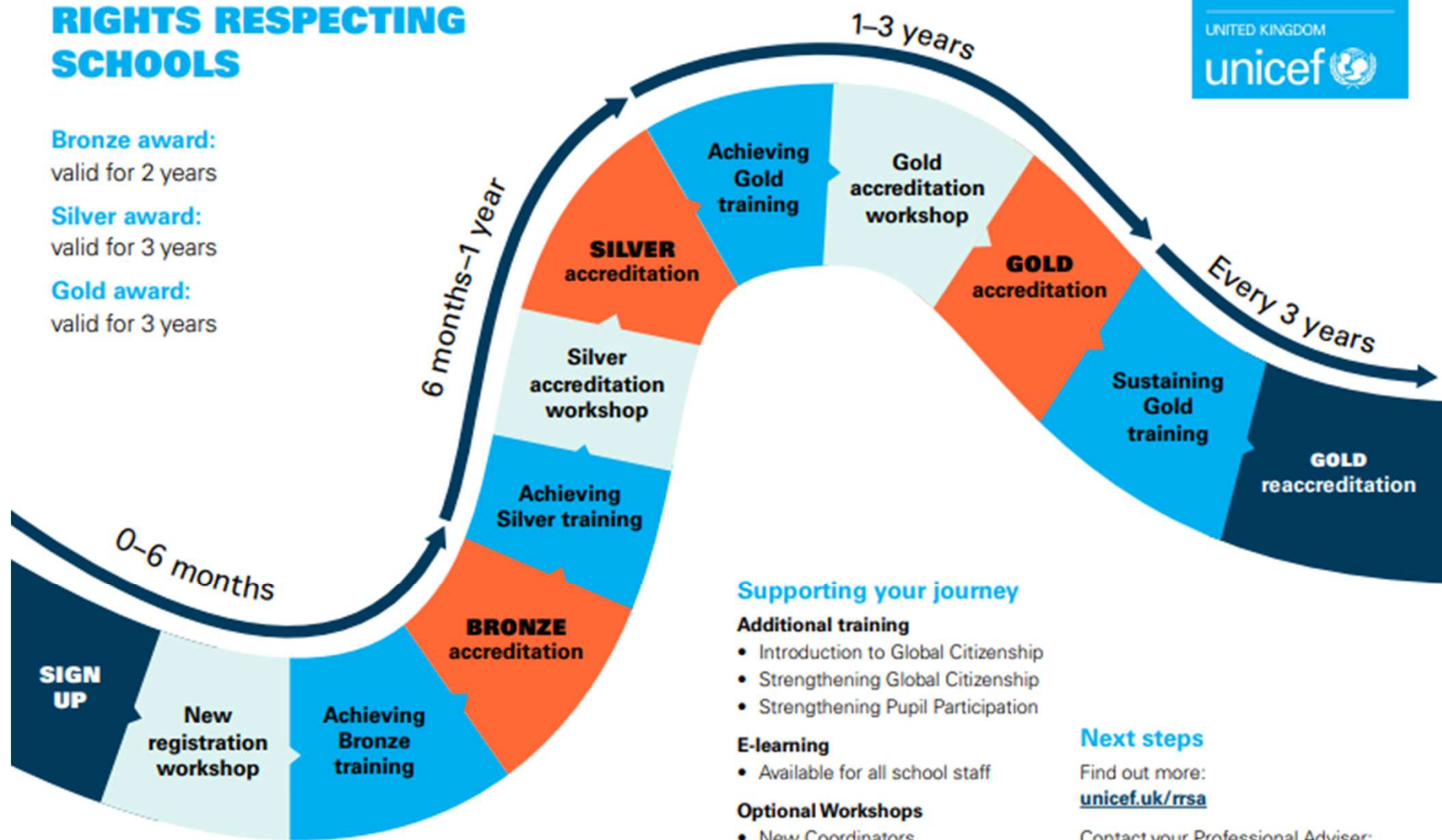

LONDON FUNDING

- RRSA funding is part of [London's Inclusion Charter](#) which aims to keep children safe and support them to thrive in school.
- It promotes the importance of children's rights in education.



What the funding covers

RRSA Membership including:

- Virtual Training sessions and online workshops for RRSA Coordinators
- E-learning for all members of the school community
- Support from a Professional Adviser
- Accreditation at Bronze, Silver and Gold
- RRSA is a membership programme and membership normally costs £2 per pupil per year, dropping to £1.25 once schools reach Gold.



BOROUGH STEERING GROUPS

- Each London Borough is being encouraged to set up a *Child Rights in Schools Steering Group*.
- Members may include senior leaders of Gold RRSA schools, local authority officers e.g. the lead for inclusion, safeguarding, SEND or children's rights.
- Steering groups will promote children's rights in schools across the borough.
